



## **FORWARD SELECT INCOME FUND**

### ***Statement Pursuant to Section 19(a) of the Investment Company Act of 1940***

On December 28, 2015, Forward Select Income Fund paid a distribution on its Investor Class, Institutional Class, Class A, Class B, Class C and Advisor Class shares of \$0.337367, \$0.361553, \$0.336722, \$0.305704, \$0.307340 and \$0.358013 per share, respectively, to shareholders of record at the close of business on December 24, 2015. Under U.S. generally accepted accounting principles ("GAAP"), the fund estimates that 100% of that distribution is paid from long-term capital gains. A long-term capital gain distribution does not necessarily reflect a fund's investment performance and should not be confused with "yield," "income" or "profit." You should not draw any conclusions about the fund's investment performance from the amount of this distribution.

The amount and sources of distributions reported in this notice are only estimates in order to comply with SEC regulations and are not being provided for tax reporting purposes. The characterization of fund distributions for federal income tax purposes is different from the GAAP characterization presented above. The determination of what portion of each year's distributions constitutes ordinary income, qualifying dividend income, short- or long-term capital gains or return of capital is reported to shareholders on Form 1099-DIV, which is mailed in early 2016 for the 2015 calendar year.
