Salient Funds 2016 Preliminary Capital Gains Distribution Information

The Salient Funds identified in the tables below will pay any available annual short-term and long-term capital gains distribution in December 2016. The preliminary capital gains information presented below is as of September 30, 2016. Salient Funds not listed in the tables have no net gains to be paid as of September 30, 2016. Actual distribution amounts will be based on gains and losses realized through October 30, 2016, and each fund's capital gains distribution amount per share will be the same across all share classes.

During each calendar year, mutual funds realize gains and losses from selling securities in their portfolios. Tax laws require mutual funds to distribute the net gains from these sales to shareholders by year-end. Distribution information can change prior to the fund's actual record date in December depending on current market conditions and the number of fund shares outstanding. When distributed, net short-term capital gains are generally taxable as ordinary income and are reported as ordinary dividends on Form 1099-DIV.
