



Salient MLP & Energy Infrastructure Fund

Section 19(a) Notification of Sources of Distribution

On February 20, 2019, the Salient MLP & Energy Infrastructure Fund (the “Fund”), an open-end management investment company paid a distribution on its Class A, Class C, Class I and Class R6 shares of \$0.07736, \$0.06870, \$0.08000 and \$0.08104 per share, respectively to shareholders of record at the close of business on February 15, 2019. **No action is required on your part.**

The following table sets forth the estimated amounts and sources of the current distribution for purposes of Section 19 of the Investment Company Act of 1940, as amended. In accordance with generally accepted accounting principles, the Fund estimates the following percentages of the total distribution amount per share attributable to net investment income and return of capital or other capital source.

The amounts and sources of distributions reported in this 19(a) Notice are only estimates, are likely to change over time, and are not being provided for tax reporting purposes. A final determination of the tax character of distributions paid by the Fund will not be known until the completion of the fiscal year. The actual amounts and sources of the amounts for accounting and tax reporting purposes will depend upon the Fund’s investment experience during the remainder of its fiscal year and may be subject to changes based on tax regulations. The final determination of the tax character of the distributions paid in 2019 will be reported to shareholders in early 2020 on Form 1099-DIV.
