Section 19(a) Notification of Sources of Distribution

On June 28, 2021, the Salient Select Income Fund (the "Fund"), an open-end management investment company paid a distribution on its Class A, Class C, Institutional Class and Investor Class shares of \$0.27632, \$0.22810, \$0.29674 and \$0.27843 per share, respectively to shareholders of record at the close of business on June 23, 2021. **No action is required on your part.**
