Section 19(a) Notification of Sources of Distribution

On September 25, 2019, the Salient Select Income Fund (the "Fund"), an open-end management investment company paid a distribution on its Class A, Class C, Institutional Class and Investor Class shares of \$0.24327, \$0.20960, \$0.26501 and \$0.24555 per share, respectively to shareholders of record at the close of business on September 24, 2019. **No action is required on your part.**
