Section 19(a) Notification of Sources of Distribution

On June 25, 2020, the Salient Select Income Fund (the "Fund"), an open-end management investment company paid a distribution on its Class A, Class C, Institutional Class and Investor Class shares of \$0.20961, \$0.18754, \$0.22629 and \$0.21050 per share, respectively to shareholders of record at the close of business on June 24, 2020. **No action is required on your part.**
